DOÑA ANA COUNTY RESOLUTION NO. 2022-80

RESOLUTION REVISING AND SETTING FEES FOR PERMITS AND SERVICES PURSUANT TO THE DOÑA ANA COUNTY ANIMAL CONTROL ORDINANCE NO. 328-2022.

WHEREAS, at its Regular Meeting of October 25, 2022, the Board of County Commissioners adopted Ordinance No. 328-2022, which was recorded on October 28, 2022and will become effective on November 28, 2022; and

WHEREAS, Section 134-20(A) and Section 134-25(B) of said Ordinance authorize the Board of County Commissioners to set the permit fees by resolution; and

WHEREAS, the Board of County Commissioners has been informed by the Animal Control Division about the types and amount of fees charged by other local jurisdictions for similar services and permits; and

WHEREAS, the Doña Ana County Animal Control division houses animals who may be considered evidence in pending criminal or civil proceedings ("evidence animals"). Evidence animals are animals involved in cases such as animals injuring and killing livestock, vicious and or dangerous or potentially dangerous animals and cruelty cases; and

WHEREAS, the Board finds that the following fees are reasonable and should be imposed pursuant to the Ordinance,

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of County Commissioners of Doña Ana County, New Mexico, that Doña Ana County Code §179-21 shall be amended and the following fees shall be charged, in accordance with the terms and conditions of the Doña Ana County Animal Control Ordinance No. 328-2022, and any fees not listed below shall remain unchanged:

- 1. Pet Licensing fees repealed
- 2. Intact Animal Permit
- 3. Litter Permit
- 4. Multiple Animal Site Permit
- 5. Dead Animal Removal Fee
 - a. Senior Discount-72 or older
- 6. Owner Relinquish Transport Fee
 - a. Senior Discount-72 or older
- 7. Potentially Dangerous Dog Registration Fee
- 8. Dangerous Dog Registration Fee
- 9. Special Permits
 - a. Outdoor Rehabilitation Aviary
 - b. Birds of Prey
 - c. Certain Snakes
